This past month has been one of preparation and a bit of re-building I would say. Following the annual meeting, I've been working with choir members and musicians to develop a worship plan going forward as well as to hear their concerns. I'm pleased that they are taking ownership over this area of worship, and I'm looking forward to getting into a routine for the next few months.

I've also been preparing for Lent the past few weeks. We've started our film series, which I'm hoping will stir some interesting conversation among the participants, and we had a very small, but I hope meaningful, Ash Wednesday service. I'm hoping to use Lent as a time to invite folks to reflect on their faith and even to begin to talk more about their faith as I think those on the outside of a church family, considering joining ours, want to see a community that is spiritual and engaging difficult questions of faith.

In terms of preparation, I'm also looking ahead toward wedding season – planning for 5 weddings currently, and offering marriage prep to 2 other couples. I hope I can be a good representative of the love and hospitality of our church family to these couples.

One exciting thing this past month or so for me personally has been meeting online with a group from Conference, and discussing the Unsettling Goods Campaign of the United Church, which is a way we're encouraged to divest from products and companies that support the Israeli occupation of Palestine. More broadly, we're seeking a way to educate those in the Conference churches on the conflict there. This is an issue near and dear to my heart after travelling there in 2011. We've decided to create YouTube Bible study videos for the Easter season that will educate viewers on the situation there, and invite them into a time of reflection.

I traveled this past month as well to Bottineau, ND to meet with other clergy from Northwest ND.

Lastly, I would say I'm so pleased with how Warm Welcome is going this winter, and am so thankful to St. Paul's for their on-going support. We've only got a couple weeks left, but the board is already busy thinking about next year and how we can support our guests and volunteers even more.

March 7, 2014 – attended the World Day of Prayer Service held at St. Giles Anglican Church; the focus this year was on the women of Egypt, parched land and living water, figuratively and literally and spiritually. Toward the end of the Service, the presenter invited us to turn to someone near us and talk for two minutes about a time in our lives when we experienced 'desert times', living water and seeing God in these things. If anyone is interested, ask me about my conversation with a young woman. To me, it was profound.

March 9, 2014 – Offered Green Fundraiser – Vesey's Seeds and Bulbs - to the congregation in the Narthex (and until March 20, 2014 - last day to order); seemed to be good amount of interest.
