General Council 42 Report

Biggest item was the Comprehensive Review Report. Most of the proposals were accepted either slightly changed or approved as proposed: more fluid governance, less bureaucracy, more autonomy for congregations. Structural changes will be studied for another 2 years, going into remits that must get 2/3 majority of approval of all pastoral charges to proceed.

A wide range of social justice and environmental issues were also discussed. Partnerships recognized with churches in Philippines, Korea and USA. New moderator chosen, Jordan Cantwell of Saskatchewan.
