#### Bereavement /Loss Concerns:

In reviewing my notes, I found that considerable time this past month was devoted to these two concerns. To summarize:

- deaths of three people at Hillview Manor all of whom I have visted with over the last four years,
- visits and conversations with their families; attendance at two funerals.
- listening to and supporting two people whose loss of sight has
  accentuated in the past few months—one person grieving her loss and
  trying to regain her sense of optimism while the other, seems firmly in
  denial- even though her world is getting smaller.
- listening to and supporting people experiencing loss of physical ability, falls, the reality of and transition to different seniors housing as opposed to 'being in my own place'.
- an elderly and vibrant person grieving the accumulated deaths and illnesses of younger friends and family members.
- listening to and supporting those having extended waits for surgery while dealing with chronic pain or who have been told by medical community that they are not eligible for treatment that would perhaps relieve their pain.
- several seniors dealing with varying degrees of memory loss, confusion or disorientation.
- prayer shawls have been presented –one for health concerns, one for bereavement.

- Max, age 5 getting his smile back after having Bell's Palsy.
- November 29<sup>-</sup> 2015 First Sunday in Advent Service at Creighton Lodge many people attended and took part.

- New to us, donated furniture in Rm 202. Prayer Shawl group is very thankful!
- Interesting discussions during Bible/book study.
