Each person is gradually adjusting to her new surroundings, although in very different ways,

Worship

Worship leader: Kim Looyenga

Importance of meeting together (Hebrews 10:25). Everyone has different gifts and backgrounds, but together we make a whole. Sometimes it's hard to work as a group, but we all serve the same God and are here for the same purpose.

Guest speaker: Roman Chernykh

Roman grew up in Soviet-era Ukraine with the drab sameness of housing, clothing and behavior. As a teenager he admired Western music and dress, and chaffed at police and KGB shadowing for minor 'offences' (receiving a letter from a US congressman).

Working on a cruise ship exposed him to many different nationalities all working together, and aroused his desire to live in a place where there's freedom, peace and the opportunity to succeed. He chose Canada after being in port cities like Halifax and St. John's. He came to Canada in 2009, gaining his Canadian citizenship just this year. He currently lives and works in Moosomin.

Roman is passionate about sponsoring community events and helping people back in his homeland. He is concerned about the war in Ukraine where a small minority want Russian presence. Most want freedom and to be able to live as Ukrainians.

Remits for Presbytery
