December 13, 2016 – on a cold, blizzarding evening, in Estevan, few people turned-out for the Blue Christmas Service, however, I choose to believe that those who took part and attended (thanks to Jason for a well-prepared Service!) found it meaningful and worthwhile.

December 16, 2016 – one person finally received a surgery date for hip replacement, January 13, 2017, and we are praying that there be no delays! Long waits for surgery sure take a toll.

Other Happenings:

December 14, 2016 – met with Julie-Anne Wallewein, Chair, St. Paul's IPC Ministry Committee, to talk about proposed wage for 2017.

December 16, 2016 - a Christmas 'elf' knitted two grocery bags full of mittens in three different sizes and many beautiful colours and had Cheryl Anseth bring them to me at the church. You know that, don't you?". On December 21, 2016 she said to me "The nights are not so dark anymore " with a twinkle in her eye and a reference to her age. We agreed there was a sermon lurking in that statement she made!!
- 3) Listening carefully when folks want/need a sounding board from intergenerational family concerns to dealing with a person who walked in and came across as a misogynist con artist.

Ordered and received a book recommended by two ministry people—A Grief Observed by CS Lewis.

Used my remaining vacation 2016 days in spending quality time with my daughter, son-in-law and grandson in Melfort, SK December 23, 28, 29, 30, 2016 returning to work January 3, 2017.

January 8, 2017 – made two hospital visits after Service on Sunday after learning both people were in acute care.

Future Plans:

I will be attending a Wellness Retreat near Saskatoon in mid-February; facilitated by Marg Janick- Grayston – An Excursion into the Land of Emotions.

During this wintery season, drive and walk carefully, maybe use 'indoor' time to do a little cleaning and sorting after the holidays and at the same time consider doing some spiritual house cleaning; it is said that confession and meditation on The Word are good for the soul!

Appendix E - Refugee Sponsorship

Last week a notice went out from a friend of mine, Rev. Jim Tenford from Moose Jaw. He had a single woman, who cares for her 5 children, residing in Moose Jaw, ask the United Church for assistance in sponsoring her husband to come to Canada. This family has lived in Moose Jaw for a while, and are selfsufficient, they make it plainly clear they can cover themselves, and are very hard workers. They children range from ages 8 to 18. They are of Somali descent. Her husband is currently in limbo in Germany. He has no status, and has tried several times to emigrate to Canada to no avail. They family is asking for someone to be a sponsoring body for the husband. An existing fund, called 'Neighbors helping Neighbors' currently sits on \$17,000 dollars, and has been for some years. It was initially created to assist farmers who were suffering from a bovine influenza of some sort, and federal assistance was not available. A few years ago, the mandate expanded to one of refugee sponsorship. After pursuing the appropriate avenues, the oil downturn began to hit Estevan. The mantra of 'Yes, we can do this!' turned into 'Estevan can't support more people this time.' The idea was put aside.

I would like to resurrect this idea. The board remains in place of this fund, and includes members of the North Portal church. I have spoken to some of them, and they support this. What I propose is a partnership with a church in Moose Jaw (Minto United Church; Rev. Linda Tomlinson-Seebach). I have no desire to separate a family from their schools and friends, but I do have a desire to help. We have the means, and the onus, and with a partner in Moose Jaw, we have the opportunity. A church to help with local arrangements, that can help with more of the day to day things required, is the partnership I propose. The family would remain in Moose Jaw, but would be more than happy to visit here, as well I would be very happy to be able to organize trips to Moose Jaw for events, work, and over all community building with the family, and with our proposed partner church. (Can you imagine a trip with our Confirmation class, to meet a refugee family with whom our church is helping reunite?) It seems a great type of outreach that can be done, recognizing Jesus call to assist those who are on the margins of society. This family walked into a United Church looking for help, let's step up and do what we are able to do. I would like our Pastoral Charge to be the sponsoring entity this family seeks. There is no guarantee about any result either, churches are still waiting for people they have sponsored. stretching into years. We can't assume anything, we can only hope and pray that we can have an outstretched hand in reuniting a family. In the meantime, the links created with this family, and this church, I believe, will be life giving for our church and congregation.

Appendix F - Access Program

One Monday, taking a rest on my comfy couch, I was flipping channels and low and behold, I saw my buddy Scott Harrison from Living Hope preaching his sermon from Sunday on Access 7. I have never before seen a local church service on a television station, and my brain started doing more thinking than it should for a Monday. On Wednesday, I asked Scott about it. He said a group of churches used to all have their services taped on a rotation, but that over the years it fell just to him.

I'd like to apply to try to get in on this. It is a wonderful opportunity to advertise for our church, and I don't care about being filmed. There is no guarantee the proposal would be accepted, but nothing ventured nothing gained!

What's The Approval Process For Possible Access7 Program Proposals? Even though we might like to, Access7 just can't produce all the program ideas we receive. So, all complete proposals are reviewed on a case-by-case basis by the Manager, Community Programming. We need to see what ideas best meet our requirements, and can be handled by our available staff and resources. Depending on how many proposals we have to consider at one time, it may take up to four weeks to make a decision.

*At every step along the way, Access7 staff will be available to answer questions and provide guidance to Community Producers as they prepare their proposals. However, we can't assess a proposal's chances of success until it's been through the evaluation process An Access7 evaluation is based on:

Available resources Available time in broadcast schedule Program concept, and how it is treated Commitment and enthusiasm of producer(s) Availability of volunteers for production and

promotion • Viewer appeal • Ideas for publicity and promotion After the proposal is considered and reviewed, a decision is made to see if it meets the necessary requirements, and can be approved for production. All applicants are notified by Access7 about the results of their proposals. Successful Community Producers whose proposals have been selected will be contacted and invited to enter into a formal production agreement with Access7.

Appendix G – Canada Summer Jobs

1. Overview

Canada Summer Jobs provides funding to help employers create summer job opportunities for students. It is designed to focus on <u>local priorities</u>, while helping both students and their communities.

Canada Summer Jobs:

- provides work experiences for students
- supports organizations, including those that provide important community services; and
- recognizes that local circumstances, community needs and priorities vary widely

Canada Summer Jobs provides funding to not-for-profit organizations, public-sector employers and small businesses with 50 or fewer employees to create summer job opportunities for young people aged 15 to 30 years who are full-time students intending to return to their studies in the next school year.

CSJ also supports the following:

- employers involved in the welcome and settlement of immigrants (including Syrian refugees) in Canada;
- employers involved in activities celebrating Canada's 150th anniversary of Confederation; and

I would like to apply for this, it doesn't hurt to try. Here is a post from a minister who used it last year (my home church in Saskatoon also used this).

Hey. Last year our congregation hired a summer student under the Canada Summer Jobs program. The federal government paid and we had a student who provided Sunday childcare, coordinated our VBS, worked on updating our music library, filled in for our admin assistant during her summer vacation...Other Ottawa churches had innovative initiatives that they had their summer student lead. It works well for congregations and for our students. The deadline for application this year is coming soon: January 20. In case you want to give this a try the link is below. For St. Paul's International they could also help with public awareness around our refugee sponsorship (See other proposal), our VBS, Sunday School leadership, a Canada 150 something, etc. What do we lose?
