Appendix B – Minister's Report

Last report (January) seems to have ended up in my grant application season – 2 have since come in (Embracing the Spirit for a youth co-ordinator to start in the summer, and the Refugee account one, which Don will talk about later in this meeting). Our grant to the federal government for summer students is still pending, and when I hear anything I will let the Leadership Team know. In January I finally finished my Marriage Prep and Confirmation courses. They are now fully digitized, built from many sources and my own thoughts, so easy to edit and change. The first Marriage Prep course finished last week, and I did edit the course quite a bit. The second course started this past Monday, and runs for six weeks. Confirmation began a few weeks ago, and runs until mid-June.

c) The Dr. A. E. Elliott Religious Training Support Fund:

In February 1979, Dr. A. E. Elliott of Grenfell, Saskatchewan celebrated his one hundredth birthday. Dr. Elliott gave long years of service to The United Church of Canada and in particular, the church in Saskatchewan. The last years of Dr. Elliott's ministry were spent in Qu'Appelle Presbytery. At the time of his one hundredth birthday, Qu'Appelle Presbytery sought a way to honor Dr. Elliott. It was the feeling of the Presbytery that a lasting tribute in the form of an educational fund be established. Rev. Gordon Stevenson and Rev. Jack Busby were charged with presenting a proposal for such a fund to Qu'Appelle Presbytery.

In February, 2018, with the anticipated implementation of Remit 1 by General Council 43 in Oshawa, Ontario (i.e., Three Council Model), which would result in the discontinuation of Presbyteries, a recommendation was presented to Twin Valleys Presbytery that would see the transfer of the management of Dr. A. E. Elliott Religious Training Support Fund to a congregation or Pastoral Charge within the bounds of the former Twin Valleys Presbytery. (Added February 2018)

The congregation approached to assume responsibility for the Fund was St. Paul's United Church, Estevan (part of the St. Paul's International Pastoral Charge). The St. Paul's United Leadership Team officially accepted this responsibility in May, 2018.

The fund shall be administered by a committee appointed by St. Pauls' United Church, Estevan, whose tasks will be to manage and promote the fund, solicit, receive and invest monies related to the fund, and distribute bursaries from the fund, according to the criteria of the Dr. A. E. Elliott Constitution. The committee of St. Pauls' United Church which is established to administer the fund may invite the ongoing participation of two or three people from the former Twin Valleys Presbytery to assist with accessing applications to the fund. Committee members to date are: Diane Wrubleski, Estevan, Barry Balls, Maryfield and Shirley Crone,

Weyburn.

St. Paul's currently holds \$15,311.25 in GIC's which we are responsible to invest and \$10,583.82 in trust for bursaries.



e) Twin Valleys Disbursement:

September 21, 2018 Motion: That at the time when the financial transactions of Twin Valleys Presbytery are completed, one third (1/3) of the remaining surplus be redistributed to the pastoral charges and two thirds (2/3) be forwarded to Region 4 (Living Skies Regional Council). Disbursement from TVP was \$973.00 (200.63/772.37)
