 The Regional Council passed the Community of Faith Profile

- November 3, 2019 is the earliest possible date that a meeting can be held. We aren't sure if we need a regional representative at the meeting.
- If we do need a representative, Vic Wiebe is available to come for a meeting on Sunday, November 3, 2019
- We should distribute the profile through email, our website, and have a few paper copies to be shared.

Pastoral Charge Committee recommend the declaration of a vacancy for a full-time ministry personnel position. In addition to this, there are plans to continue to have an additional half time lay position to assist with pastoral care, Christian Education and outreach, CARRIED.

## **Refugee Status**

- Don Kindopp contacted Letina Kahsay and Yemane Gebreusis asking them additional questions
- Latina has 4 adult cousins who are Eritrean who are refugees. Their names are Mehari Gebreslase Gebremedin, Letensae Kiros Hadgu, Habtom Kiros Hadgu and Meron Fishaye
- 1 of the cousins is from her mom's side, and the other 3 are from her dad's side.
- 3 of the cousins are currently in Ethiopia, and
   1 is currently in Sudan.
- It is recommended that we do one person at a time when applying for refugee status instead of under one big application.
- For each person, we need to have \$14,000-\$16,000 in trust, so we need to have approximately \$56,000 in trust for all 4 people. Latina assures us that she has the money.
- Waiting times is 16 months from Sudan to Canada and 32 months from Ethiopia to Canada
- Don proposed that he create a PowerPoint presentation for the upcoming congregational meeting
- Don will find out if the air fares are included in the \$56,000 fee or if that's over and above
- Don will find out if we should have legal paper work (possibly a contract or a trust agreement) between our church and Latina and her family, because it is potentially a large sum of money

The motion to be brought forward will read as, "St. Paul's United Church enter into a Memorandum of Understanding with Latina Kahsay and Yemane Gebreusis, as individual sponsors, for the Constituent Group sponsorship of Mehari Gebreslase Gebremedin, Letensae Kiros Hadgu, Habtom Kiros Hadgu and Meron Fishaye with the understanding Latina and Yemane will assume full financial responsibilities and program obligations for the sponsorship. CARRIED


