THAT St. Paul's International Pastoral Charge Community of Faith concur with the recommendation of the Search team that Koshy David be called to ordained ministry with the following terms:

Category E;

Cost of Living category 3;

Effective date of September 1, 2020;

40 hours per week (100%);

Minimum annual salary of \$60,559;

Telephone/communication allowance of \$990;

Support for continuing education at a minimum of \$1442 each pastoral year;

Minimum one month (5 Sundays) vacation;

Three weeks study leave (including Sundays) in each pastoral year;

Administrative assistance defined as full time paid admin support;

Participation in the Centralized Payroll Service; pension and group insurance payments as assessed;

Travel expense reimbursement as logged based on minimum General Council rate of \$0.42 per km (travel to place of residence not included);  
\$200 meal reimbursement annually  
and that this request be forwarded to the Pastoral Relations Commission of the Living Skies Regional Council for approval of the call/appointment. DEFEATED.
