

### d) Christmas Hampers/White Gift

- Normally each year we collect food items and White Gift donations to provide Christmas Hampers for those families in need. This year will be different due to COVID. A city-wide group is working within SHA guidelines to distribute the hampers this year. Food items will be bulk purchased and placed in hampers that will be picked up by families from the Salvation Army.
- Last year St. Paul's distributed 21 hampers to families. This year a target of 25 hampers was set. The cost of a hamper for a family of four is \$150.00. The total cost of the 25 hampers would be \$3750.00.
- Information has been emailed out to our congregations asking them to contribute a White Gift to meet this goal.
- **Recommendation**: any shortage from the goal of \$3750.00 not raised by White Gift be taken from the Benevolent T/F. This fund has a balance of \$6,752.89.
