

d) Canadian Emergency Business Account (CEBA)

- We were successful in securing at \$60,000.00 loan from the Federal Government program for hard-hit small businesses and not-for-profits. Repaying the balance of the loan on or before December 31, 2022 will result in loan forgiveness of 33 percent (up to \$20,000).
- CEBA is meant to assist in paying non-deferrable expenses incurred by St. Paul's.

e) Property Matters

- We recently had a router failure. Fortunately someone had donated an old router that was exactly the same make and model. It was reconfigured to our network and the network was restored. It is perhaps time to look and upgrade our network to a Wi-Fi Mesh system. Approximate cost \$400.00.
- Our lawn mower needs replacement. Approximate cost \$650.00
- The curbing in front of the church has deteriorated greatly over the winter. Sharilee has been in contact with Norm Mack, Public Works, City of Estevan. The city will be replacing a large portion of this curbing with rolled curbing this year. There will be no cost to St. Paul's.
- Progress and upgrading have been completed that allows Sharilee to access the United Church HUB and ADP online from her desktop computer. Also, protocols with ADP have been updated so we no longer are required to use a FAX machine. We will be removing the FAX from the office and reducing our SaskTel bill each month by the amount paid for the FAX line.
- Our GFL bin has been used by our "neighbours" a fair amount. We have ordered a similar sized bin with a locking mechanism on it.

f) Congregation Virtual Get-together

I'm suggesting that perhaps we should entertain the option of presenting a time each week where we invite our Pastoral Charge congregations to meet over Zoom. A time to bring a cup of coffee and check-in with each other. An informal time where we can visit and share what is happening within our daily lives and community. We are renewing our Zoom license on April 16, 2021 for another year.
