Annual Report Knox United Church

Knox United Church

Dear members and adherents of Knox United Church and St. Paul's-International Pastoral Charge,

It has been a quiet year. We have missed our regular services and community functions. Unlike other years, there are no luncheons or special services to report. There were no funerals, weddings or baptisms in our building.

The first time we gathered this year was to meet online for our 2021 Annual Meeting on March 14, 2021. Folks from First Presbyterian and Knox were together, and we started to consider the question of when our churches would close as Pastoral Points, and if we might sell the church building and manse.

Through prayerful conversation and reflection, we started putting some of these pieces in place. It will be a long and carefully discerned process taking place in upcoming years. The congregation of First Presbyterian withdrew their member from the Search Committee and did not attend worship services (because of the border remaining closed to private travel).

Knox church opened its doors for in-person worship services on the first Sundays of the months, starting in October. (Oct 3rd, Nov 7th, Dec 5th). Approximately 10 members were present at these services, which were beautifully led by Kathy Kyle and Sandy Dalziel, including twice having communion with Rev. Kyle. We continue to enjoy fellowship time with coffee and muffins after worship.

Our congregation voted to sell the manse and new trustees were elected (Gene Baniulis, Emily Gillies and Brenda Strong) to put a legal agreement in place between Knox and a local purchaser. The sale should be finalized in early 2022.

We appreciate the Leadership Team at St. Paul's for handling the responsibility of deciding on service schedules and coordinating pulpit supply, and we welcome Patty Schachtel as the new administrative assistant. With the exciting news of Jeri-Lee Jones becoming our new full-time minister in February 2022, we look forward to a year of meaningful work and worship in our charge!



We are thankful to Don Kindopp (treasurer) and Astrid Friesen (recording secretary) who continue to serve the leadership team so thoroughly. We are also fortunate for Vic Wiebe, from Regina, to join us as the Pastoral Charge Supervisor. He continues to offer support until we have ministry personnel.

We have many vacancies, as well as upcoming vacancies on our team and I would prayerfully ask that you consider becoming involved to help in the future life and work of our church.

A Note on Investment and Trust Funds:

St. Paul's Investment and Trust Funds are distinct amounts of monies accounted for in a separate bank account. Trust monies may not be used for the general day to day operating expenses of the church.

Monies from certain trusts such as the Capital and Benevolent funds must be spent for those purposes. Expenditures of Memorial funds are considered by the Trustee Committee and the approval of the congregation.

Monies in the Bequest Fund are those monies left to St. Paul's by an estate and have no stipulation as how they must be used. Expenditures from this fund are done upon the approval of the congregation.

St. Paul's congregation has approved the use of Bequest funds, on an annual basis, to cover any deficit and accumulated debt of the General Operating Fund.
