

# MINISTRY (& PERSONNEL) COMMITTEE REPORT

he year began with continued pulpit supply for weekly services until Jeri-Lee Jones started her position as our fulltime minister in February. Jeri-Lee was working toward completion of her Designated Lay Ministry studies through St. Andrew's College with anticipation to be formally recognized as a DLM in June 2022. Through a previous congregational vote Jeri-Lee had been elected to serve our charge by appointment as Candidate Supply from February 1-June 30, 2022. A congregational vote on May 15, 2022, to further her initial appointment was defeated, and her employment with St. Paul-International Pastoral Charge ended on June 30, 2022.

Since that time the Leadership Team has appointed the Ministry and Personnel Committee to oversee the arranging of pulpit supply for regular weekly services. There are three members of the charge: Don Kindopp,

Jim Pratt, and Emily Gillies, who regularly lead worship, and we engage the services of local Lay Leadership as provided by the Living Skies Region pulpit supply list. There are very few who can provide the sacraments of Baptism and Communion, and

as such, communion was offered only once in 2022 and there were no Baptisms.

The congregations of St. Paul's and Knox seem satisfied with the variety of services presented by this rotating leadership from the pulpit. The format of worship remains relatively consistent and certain routines, such as Birthday Celebrations on the last Sunday of the month, and clapping during 'Halle, Halle, Halle' have remained in place. The diversity of sermons preached, which are for the most

part captured on audio recording on our church's website, attests to the rich tapestry that is developing in our Sunday worship. In the absence of a dedicated minister having regular office and work hours, very little spiritual and congregational programming happens in the church outside of Sunday worship. Bible study and other gatherings have been largely on hold since Jeri-Lee's departure. The success of onetime events such as the Auditorium Sales, the Fair Booth and the Pie Sales have been gratefully realized through the dedication of St. Paul's members taking these tasks on.

We continue to explore Ecumenical Worship with the congregations of St. Giles Anglican and Trinity Lutheran. We reserve any 5<sup>th</sup> Sundays of the month for a jointly held service which rotates buildings, and the joint offerings of "Messy Church" are going well.

September 18<sup>th</sup> and 20<sup>th</sup> saw two very special conversations with the St. Paul's congregation as Emily Gillies invited a time of intentional

reflective conversation so that members could discuss their honest thoughts about where our congregation has been and where we think it has the potential to go. These two meetings were followed up with another evening discussion hosted by Tracy

Murton for further clarification of congregants' thoughts and desires.

As we review our needs, our finances and our hopes for our churches with the completion of a new Community of Faith Profile, we pray that with faithful inquiry we will soon discern the direction for the future of our Pastoral Charge and our ministry needs will become clear.

but dedicated group of approximately 10 people per service, having services on a once-per-month basis. Typically, the service is on the 1st Sunday of the month. Decisions and communication happen between members, our Pastoral Charge Administrator Patty, and the Pulpit Supply committee to ensure the dynamic and fluid worship schedule is confirmed.

We are grateful for the time Jeri-Lee Jones ministered to us, and for the capable and inspirational lay leaders that have handled pulpit supply in the interim. The social aspect of meeting for coffee and muffins after church is enjoyed by all.

We continue to enthusiastically welcome members from First Presbyterian Church in Portal to worship with us as they are able, as First Presbyterian no longer operates their building and will eventually complete the process of formal closure.

We welcome new folks and visitors to services as well, and attempt to communicate the worship schedule with interested adherents by way of text communication and word-of-mouth.

There were no baptisms, funerals, weddings, or confirmation classes in our church building this year, and no new memberships were initiated.

Our church family mourned the passing of Margaret Baniulis in November 2022, and our continued prayers for God's grace and ease to go Gene, Logan, and Kyle.

Margaret's funeral took place at St. Paul's United Church, on November 25<sup>th</sup>, with Sandy Dalziel officiating. Margaret's vibrant and efficient presence in our church family is sadly missed.

Maintenance of our church building is very minimal. Gratefully, the Village handles the grass cutting and snow removal. The plumbing, electrical and structural systems of the church building have all been in good working order.

The digital piano is experiencing sporadic technical difficulties. A service provider would have to come from a distance and it would be a large expense with no guarantee of fixing a 25+ year old instrument, so an acoustic upright model will likely be obtained and brought to the church for ease of regular use. We also installed and began using a different organ this year, as the one that had formerly been Pearl Davis' had stopped working. We are grateful to the Pastachak Family of Bienfait for providing to us, at no cost, the new one in memory of Norma Pastachak.

There were two rentals in our building, notably that Village hosted a Luncheon following the CP Rail Holiday Train on December 18<sup>th</sup>, and the Carlberg family enjoyed the space for their Christmas gathering.

The pool table that had been in the Youth Group Room was given away, at no cost, to the Estevan Public Youth Centre, in March. They were very happy to receive this donation as they open their doors to the youth of our area in Grades 7-12 for regular programming and drop-in times.

The biggest change in the year 2022 was in January when we completed the sale of our Manse to Callie Fair. All transactions are

complete as of March 2022 and we wish Callie all the best in her new home sweet home.

We continue to be grateful for the time and talents of Vivian Lindblad and Dorothy Fuchs who aptly handle the financial details for our congregation, and for our brothers and sisters in St. Paul's congregation who work very warmly with us as we approach a new time of Discernment and Search in our Pastoral Relations.

May God's wisdom and favour be with us all in 2023.

I made seven knitted blankets out of some of the remaining yarn for the Homestead Shelter for Women in

southeast Saskatchewan and plan to continue making more with what is left.

The leftover material and notions were put out again during the Church's Christmas Bazaar. We were able to sell many more items. On occasion, I get a call from someone, who is looking for material for a project, so the inventory keeps decreasing. In the spring, I plan to take what is left to the Salvation Army in Regina and donate it to their cause. Until that time, if anyone is wanting something, please give me a call. Every sale counts.

#### **Auditorium Sale**

#### **Christmas Bazaar**

We hold these funds in trust as a Constituent Group for the refugee family of Letina Kahsay in accordance with the November 8, 2019 Memorandum of Understanding with Letina Kahsay and the August 31, 2021 Memorandum of Understanding with Letina Kahsay.

#### A Note on Investment and Trust Funds:

St. Paul's Investment and Trust Funds are distinct amounts of monies accounted for in a separate bank account. Trust monies may not be used for the general day to day operating expenses of the church.

Monies from certain trusts such as the Capital and Benevolent funds must be spent for those purposes. Expenditures of Memorial funds are considered by the Trustee Committee and the approval of the congregation.

Monies in the Bequest Fund are those monies left to St. Paul's by an estate and have no stipulation as how they must be used. Expenditures from this fund are done upon the approval of the congregation.

St. Paul's congregation has approved the use of Bequest funds, on an annual basis, to cover any deficit and accumulated debt of the General Operating Fund.
